Pre-College Scholars Virtual Program has strict academic conduct and online community policies to protect my health, safety, and academic integrity as well as the health, safety, and academic integrity of other program participants. I understand that failure to abide by the UC Berkeley Pre-College Scholars Virtual Program policies may put my health, safety and academic performance at risk and may endanger other program participants. It is my responsibility to follow all the rules and regulations in place as outlined in, but not limited to, the Berkeley Campus Code of Student Conduct, the UC Berkeley principles of community, the Campus Online Activities Policy, and any policies designated by individual faculty and instructional staff. The later policies may include rules and guidance regarding the sharing of class learning materials (e.g., videos, exams, problem sets, case studies, etc.), permitted forms of collaboration, and other behaviors related to remote learning and teaching. Policies for this program are governed by the UC Berkeley Activities Involving Minors Policy.

Any violations of the UC Berkeley Pre-College Scholars Virtual Program policies may result in monetary fines, probation, criminal prosecution, and/or immediate dismissal from the program. All fines and penalties are my sole responsibility. By signing this document, I indicate my understanding and acceptance of the regulations and disclosures it contains.

- ☑ I agree to abide by all program policies, including, but not limited to, full participation in all orientations, registered classes, and those programs or advising activities classified as "mandatory".
- ☑ I agree to observe and abide by all the policies of student conduct and program rules for all the UC Berkeley Pre-College Scholars Virtual Program activities, such as, but not limited to, my participation in online orientations, online programing and activities, and online class meetings.
- Except in case of a serious illness I agree to attend all required online class meetings on time. If I am to be absent, I will make sure to inform the instructor in a timely manner.
- ☑ I agree to take all required exams, and submit all coursework by the stated deadlines from instructional staff or as noted in the course syllabus.
- ☑ I agree to show respect and courtesy to all members of the university community, including fellow students, staff, instructors, volunteers, campus online community, and affiliates.
- ☑ I agree to treat online class meetings as if attending class on campus, use methods of expression that are appropriate for a healthy learning environment, not use obscene, derogatory, or abusive language, and treat others with courtesy and respect.
- ☑ I agree to wear appropriate clothing and avoid inappropriate surroundings when attending online meetings.
- ☑ I agree to not join online meetings while driving or riding in a car, and only join from a suitable, quiet location, with a device that permits full participation in class activities.
- ☑ To protect the privacy of the UC Berkeley Pre-College Scholars Virtual Program community from unintentional harms as well as any external interference, I agree to never use recording devices of any kind during online meetings.
- ☑ I agree to never distribute any learning material made available to me during class (e.g., videos, exams, problem sets, case studies, etc.), outside the program, whether such distribution occurs online, electronically, or otherwise, without first obtaining the instructor's written permission.
- ☑ I agree to not engage in any form of harassment or bullying. Harassment includes but not limited to, cyber, written, verbal, graphic, physical, and sexual misconduct.
- ☑ I agree to uphold high standards of academic integrity, including producing work that is my own creation, and meeting intellectual challenges through honest effort and hard work.
- ☑ I agree to not commit, or threaten to commit acts of violence on people or property.
- ☑ I agree to adhere to all federal, state, and local laws.

I understand that violations of the following policies may lead to **immediate** dismissal from the UC Berkeley Pre-College Scholars Virtual Program and that all fines and penalties are my sole responsibility:

- ☑ Regardless of student's age or the location from which they are attending the UC Berkeley Pre-College Scholars Virtual Program, possession or consumption of cigarettes, vapes, Juuls, alcohol, illegal or recreational drugs (including marijuana) will result in serious disciplinary actions and/or dismissal from the program.
- ☐ Harassment, assault, bullying, or sexual misconduct will result in serious disciplinary actions and/or dismissal from the program.
- Any type of disrespectful, exclusionary, discriminatory, threatening, aggressive, or abusive behavior is strictly prohibited. Discrimination against a person's race, color, religion, sex, national origin, age, disability, veteran status, sexual orientation, or gender identity or expression will result in serious disciplinary actions and/or dismissal from the program.
- ☑ The deliberate sharing of private images, communications, learning materials or other depictions of other students, staff, or instructors for the purpose of inviting external commentary, ridicule, or embarrassment, is prohibited and will result in serious disciplinary actions and/or dismissal from the program.



☑ I further understand that these policies and regulations are for my safety and that of other program participants, and cannot realistically cover all situations. The Assistant Dean of UC Berkeley Summer Sessions, along with the Pre-College Scholars Program team will determine if any rules or policies have been violated and what disciplinary action, if any, should be taken.

## Attendance Guidance and Recommendations for Required One-on-one Interactions with Faculty and Staff Virtually:

In order to protect the privacy of the UC Berkeley community; parents, friends, or family members are not allowed to participate in online class meetings. Enrolled students should be the only participants attending sessions unless an exception has been made through the academic departments and/or instructors to accommodate a student's disability.

But in situations requiring one-on-one interaction with faculty or staff members during the program (ex. Attending faculty office hours, advising ...), students are encouraged to do the following:

- Attend the meeting with the knowledge of their parents or legal guardians.
- If possible, attend the meeting from an open space in your home and not in a closed room, (ex. living room is an ideal option).
- Request that another adult attend the meeting with them (ex. GSI, parent/legal guardian).
- Always copy their parent/legal guardian, GSI, or adviser as appropriate in all their email correspondence during the program.

I understand that the University reserves the right in its sole discretion to cancel the program or any
